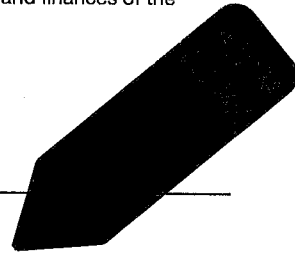

MAC is staffed by highly trained professionals with a variety of behavioral health certifications and licensures. Our services utilize several therapeutic modalities, including applied behavioral analysis (ABA) therapy. Mac's services are center-based and in-home, and include speech and occupational therapy, assessment and diagnostic services, and individual and family therapy. Mac provides services to clients age 18 months to 21 years old throughout the state of Minnesota. Programming is tailored to accommodate client and family specific needs and goals.
